Motion 4: The Association has the responsibility to respond to emergencies that arise. Snow on roads is not an emergency situation and cannot be funded by the Association from this day on (July 20,2019) – passed

Motion 5: The Board of Directors submit a change to by-law 3 that says "At least one member of the Board of Directors live in the Association full time" and put that out to members for a vote – passed

Motion 6: The Association hire a non-association member and non-homeowner for bookkeeping and not to exceed \$500 for a professional website manager – passed

Motion 7: The Board submit a ballot for a by-law change to the membership to amend by-law 34 to say "A member in good standing may obtain up to five (5) proxies for each tract or parcel owned". The ballot can be on the back of the proxy.
